INSTRUCTIONS FOR COMPLETING YOUR "LETTER OF INVITATION"

Each client intending to bring firearms into the Republic of South Africa (RSA) must submit the required documents to the South African Police Service (SAPS) in order to obtain approval for the importation of those firearms. A Letter of Invitation (LOI) from a licensed African Outfitter is one of the necessary documents that must be presented to SAPS. Following herewith are the instructions necessary for the client to complete the required LOI.

The LOI contains enumerated items 1-6 that must be completed accurately and legibly. Enter the information for each enumeration as follows:

Number 1: For married couples traveling together, in 1[A] and 1[B] enter both names exactly as appears on your individual passports. Alongside your name, enter your passport number. If you are traveling alone (that is, without a spouse), enter the same information in 1[A] and delete 1[B] so that only the words "AND NO OTHERS" appears after your names. If you are a married couple traveling with dependent minors, add additional letters, [C], [D], etc. to cover the additional dependents.

Number 2: List your physical address exactly as it appears on your passport.

Number 3: List the dates that you will actually be present in RSA. By way of example, if your flight lands on 07/05/20, you begin hunting on 07/06/20, end hunting on 07/15/20, but do not depart RSA until 07/20/20 then the dates you must enter are 07/05/20 – 07/20/20 because those are the inclusive dates in which you will be in RSA with your firearms.

Number 4: List the plains game species you intend to hunt. This should come directly from Schedule A of your safari documents.

Number 5: List the dangerous game species (elephant, cape buffalo, lion, leopard, rhino, hippo or crocodile) you intend to hunt. If you are not hunting dangerous game, enter "None".

Number 6: Under 6 [A],[B],[C] list the specifics on the firearms you are importing. This allows for 2 rifles and a shotgun, or other mix of firearms up to a total of 3. If you feel you need to import more than 3 firearms then please speak to us. Our experience tells us that traveling with even 3 firearms and associated ammunition is quite burdensome and unnecessary and that the traveling sportsman can easily get by with only 2 firearms, or even just 1. For married hunters traveling together and each needing a separate firearm, the need for additional firearms is easily justified, but even in those instances 3 will generally suffice. Make sure a data entry appears under each of the headings appearing herein. Note that serial numbers are not required. Under OWNER the name that appears must be the same as appearing on the respective CBP Form 4457. Delete any lines [B] or [C] that are not needed so that the words "AND NO OTHERS" precisely follow the last firearm you have listed.
